Five farmers from each of 15 villages will cultivate potatoes using Aastha Organics products on 30 decimal land. This partnership will also enable farmers to sell their produce directly to Aastha Organics, with all transactions facilitated through Baghlata FPO, ensuring both sustainable practices and market access.
